- Images should be 300dpi. Embed all images or supply linked images.
  - Outline all fonts or supply fonts used.
  - All art to be CMYK color mode. Convert RGB color before sending files.
  - Extend images to the bleed line.
  - Keep text within the LIVE AREA.
  - Place art on art layer.
  - Turn off instruction/template layers before submitting final PDF file.
  - Supply Native files in addition to print ready PDF. Do not flatten Native file(s)

Sustainable capsules in 3 easy steps  
1 cool 2 peel 3 recycle  
Allow at least 2 minutes to cool capsule.  
Carefully peel foil lid off & remove filter with coffee grounds.  
Compost grounds & filter or discard.  
Recycle plastic capsule wherever #5 recyclables are accepted.

4. Preform a cleansing cycle when brew cycle is completed
